## Biographical Note by The HistoryMakers®

Born to educators Richard and Vernelle Lillie on April 7, 1952, Charisse Lillie was made aware of the importance of service and education, and has made both part of her own legal legacy. Lillie received her B.A. from Wesleyan University in 1973, her J.D. from Temple University Law School in 1976, and her LL.M. from Yale University in 1982. Throughout her distinguished career, Lillie has shown a profound commitment to affecting change through the law. Among the first generation of students to integrate Houston's public schools in the 1960s, she was aware that attorneys were critical to dismantling the laws of segregation.

As a college student, Lillie wrote a monograph on the careers of African American federal judges. This experience helped shape her career by putting her in contact with early giants. After receiving her LL.M., Lillie taught law at Villanova University in Pennsylvania before embarking on a distinguished career in government service as assistant U.S. attorney for the Eastern District of Pennsylvania (Civil Division) from 1985 to 1988, general counsel to the Redevelopment Authority of Philadelphia from 1988 to 1990, and as city solicitor for Philadelphia from 1990 to 1992. She joined Ballard Spahr Andrews & Ingersoll in 1992.

Serving as partner and chair of the litigation department of Ballard Spahr Andrews & Ingersoll, Lillie's practice centers on discrimination defense. She lectures widely and serves as an adviser on issues such as diversity, anti-discrimination and affirmative action. Lillie serves on countless boards, committees and organizations and was most recently appointed chairperson of the board of the Federal Reserve Bank. She is the recipient of numerous awards, including the Whitney M. Young, Jr. Award from the Urban League of Philadelphia. Lillie is married to Thomas McGill, Jr. and has one daughter, Alison McGill.

# **Detailed Description of the Collection**

### **Series I: Original Interview Footage**

Charisse R. Lillie describes her family background and childhood. Lillie was born on April 7, 1952. Her mother, HistoryMaker Vernell Audrey Lillie was born on May 11, 1931 in Houston, Texas. Her family settled in North Carolina after slavery and migrated to Oklahoma before settling in Houston, Texas. Lillie's maternal grandfather worked as a funeral director until World War I, when he began working at Hughes Tool Company. Lillie's father, Richard Lysander Lillie was born on July 29, 1931 in Houston, Texas. His mother was

from Sealy, Texas and his father was from New Iberia, Louisiana. Lillie's mother was a drama teacher at Phillis Wheatley High School and a professor at the University of Pittsburgh and her father was a teacher and jazz musician. Lillie grew up in the Pleasantville neighborhood of Houston, Texas and attended Turner Elementary School, St. Peter the Apostle Middle School, and Mt. Carmel High School, as well as a summer camp at Phillips Academy in Andover, Massachusetts in 1968 and 1969.

Charisse R. Lillie describes her education. After graduating from Mt. Carmel High School in Houston, Texas in 1970, Lillie enrolled at Wesleyan University in Middletown, Connecticut as part of their first class of freshman women. At Wesleyan, Lillie was active in the Ujima organization of African American students and was mentored by Professor Clement Vose, with whom she wrote a paper on black federal judges. While researching this paper, Lillie interviewed fourteen of the fifteen black federal judges, including Judge Clifford Green and Judge Leon Higgenbotham. After graduating from Wesleyan, Lillie attended Temple University Beasley School of Law in Philadelphia, Pennsylvania, where she met HistoryMaker H. Patrick Swygert and Drew Days. After receiving her J.D. degree, Lillie worked for two years as law clerk for Judge Clifford Green, two years as a trial attorney in the Justice Department, and one year as Deputy Director of Community Legal Services in Philadelphia before enrolling at Yale Law School.

Charisse R. Lillie describes her recent career. After obtaining her LL.M. degree from Yale Law School in 1982, Lillie became a law school teacher at Villanova University in Villanova, Pennsylvania and also became active in many organizations. Lillie was then hired as the Assistant U.S. Attorney for the Eastern District of Pennsylvania in 1985, General Counsel to the Redevelopment Authority of Philadelphia from 1988, and City Solicitor for Philadelphia from 1990 to 1992 under HistoryMaker W. Wilson Goode. In 1992, she joined the firm of Ballard, Spahr, Andrews & Ingersoll, where she became chair of the litigation department. Lillie also served as Chair of the Board of the Federal Reserve Bank of Philadelphia and in 1999 began serving as chair of the American Bar Association Commission on Racial and Ethnic Diversity in the Profession. Lillie also shares her opinions on legal questions in the African American community such as affirmative action and reparations.
